ALTERNATIVES

As part of a **comprehensive university**, LSM offers access to **other faculties** of the UCLouvain to its exchange students. It is also possible to take courses from other faculties (economics, engineering, political science, etc.).

However, the other UCLouvain faculties **do not work on the same schedule** as LSM's 6-week intensive teaching. Other faculties offer courses over the entire semester. Due to this difference in schedule, it is almost **impossible to avoid overlaps** with LSM courses.

If you are interested in taking courses outside LSM, please refer to the following rules:

- No more than **3 courses** outside LSM
- It is the student's responsibility to check the **schedule, prerequisites, and entry requirements**
- It is the student's responsibility to handle any **subsequent problems or overlaps**
- **Delay in transcript** of records may occur as all faculties do not have the same grade release date.
