OVERVIEW

The Sauder School of Business is pleased to welcome exchange students to join our Master of Business Administration program for **Fall 2022***. We are a popular destination for MBA exchange students from schools throughout the world for our strong teaching and research reputation, international diversity and our spectacular natural setting.

The University of British Columbia (UBC), established in 1908, is one of Canada's leading research universities and is consistently ranked among the top 40 in the world. The university attracts 61,113 students from across Canada and 140 countries around the world to two major campuses.



Vancouver Campus

The largest campus is 30 minutes from the heart of downtown Vancouver, a spectacular location that is a 'must-see' for any visitor to the city — where snow-capped mountains meet ocean and breathtaking vistas greet you around every corner. MBA EXCHANGE ACADEMIC OVERVIEW

Term Dates: The Exchange Term covers two periods within the **Fall 2022***

Period 6: **September 6 – October 15, 2022****

Exam week: October 10 – 15, 2022

Break (no scheduled classes): October 17 – 30, 2022

Period 7: **October 31 – December 10, 2022****

Exam week: December 5 – 10, 2022

*For Fall 2022, UBC is planning for in-person instruction.

**Dates are subject to change

Students take 4 courses per each Period.

Note: Professional Development seminars are held throughout the term. Exchange students may request to participate along with the Full-Time MBA class.

Structure and Delivery of Classes: Lectures, seminars, case studies, project works, group work, presentations and field trips.

Language of Instruction: English

Teaching Hours: 1 Course = 1.5 credits or 20 credit hours (note: Exchange students take 8 courses over two periods from September to beginning of December)

Class Size: 50 students max in class; average 26 students in a class.

Course Load: 4 courses per period (8 courses over duration of Exchange term)

Grading: Percentage system used; 60% = Minimum Pass

Examinations: Final Evaluations are held during the last week of class (during week 6 of each of Period 4 and Period 5). Final evaluations may involve a written examination and/or oral presentation, written paper, or assignment.

COURSES: SELECTION & REGISTRATION

Course listing for Periods 4 and 5 will be made available to incoming Exchange Students in June 2021.

Registration will open for all MBA students (including Exchange students) in mid-July. Registration is facilitated by our online system, the details of which will be sent to exchange students in late June for enrolling in selected courses.

Students looking to secure off-campus accommodation should expect to spend \$1,000 – \$1,500 CAN per month for a 1 bedroom accommodation.

Medical Insurance: Exchange students at UBC are required to be enrolled in the IMED: Health Insurance for New International Students. There is a charge of \$252 CAD* for this insurance which will provide basic medical coverage during the exchange term.

Orientation & Tour of Vancouver: To assist students in assimilating to life at the Sauder School of Business, the University of British Columbia and Vancouver, a one-day mandatory Exchange Student Orientation is held on **Sept. 1st** and the Tour of Vancouver on **Sept. 2nd**

ESTIMATED EXCHANGE EXPENSES

Exchange students are exempted from paying UBC MBA tuition since tuition is paid to the home institution. The following fees and expenses are only ESTIMATES for a single student and are subject to change without notice. Expenses are in Canadian dollars and may vary depending on the student’s own personal spending habits.

STUDENT SERVICES

Exchange Buddy System: The MBA Student Society (MBAS) organizes a buddy-system for Exchange students to help new students get acquainted with their peers in the MBA program and to answer questions, give guidance/advise and ensure students feel comfortable in their new environment. Exchange students are invited to social events organized by the MBAS.

Business Career Services: The Business Career Centre (BCC) is available to Exchange students. Services are available upon request and can include:

HEALTH INSURANCE - IMED

iMED is temporary, mandatory health insurance. You are automatically enrolled once you are registered in UBC courses.

You will get your iMED card after you confirm when you will travel to Canada, starting from 3 weeks before your travel date, to activate iMED coverage for your arrival. After you have confirmed your arrival date, David Cummings Insurance Services (DCIS) will email your iMED card to the email address you provided to UBC.

Check your inbox and junk-mail folders. Print your iMED card and keep it with you at all times. If you don't receive your iMED card, please email DCIS at info@david-cummings.com. iMED costs \$315 (Canadian dollars) for single-term exchange students at UBC (4 months of coverage), plus a \$9.74 direct billing fee.

With your iMED card, you don't have to pay for your visit if you see a doctor at the Student Health Service at UBC or the University Village Medical and Dental Clinic in the Village on campus. Also, iMED covers emergency hospitalization and medical services (including outpatient treatment at a doctor's clinic) for an unexpected sickness or injury.
